August 2, 2021

CALL TO ORDER:

President David Hall called the meeting to order at 7:00 p.m., at which time the Pledge of Allegiance was recited.

MINUTES:

• July 6, 2021

The minutes from the July 6, 2021, meeting were reviewed. D. McCumber motioned to approve the minutes as presented. B. Beardsley seconded. The motion carried unanimously.

ACCOUNTS PAYABLE:

Expense Approval Report

D. McCumber motioned to approve the Accounts Payable Report as presented. G. Henning seconded. The motion carried unanimously.

PUBLIC COMMENTS:

Tom Huber, 196 Eastwood Drive, commented on the milling and repaving of Eastwood Drive and thanked Mark Hamman for handling any issues and overseeing the paving project. T. Huber stated the neighborhood looks better than it has in twenty years.

T. Huber mentioned the article in the News Journal stating the Borough authorized distribution of \$60,000.00 to the underpass murals and believes the money could be utilized better.

Bob Behrens, Jr., 97 Wall Street, suggested repairing the stairs in the underpass with the \$60,000.00. P. Gehrlein stated the money is from the Erie County Gaming Revenue Authority with an amount set aside for underpass improvements. The Borough is working with PennDot regarding the infrastructure improvements to this area. P. Gehrlein stated he believes the infrastructure, improved lighting, and improved safety for pedestrians is critical.

B. Behrens stated as a trial run to the Residential Rental Inspection Program, he asked Mark Hamman to walk through one of his units to do an inspection but was told there is currently no checklist for the program. P. Gehrlein stated at the last landlord meeting, it was agreed upon the landlords would meet and comprise an alternative checklist and then have a meeting to agree upon the parameters in which to inspect the properties. Prior to that, P. Gehrlein stated it was inappropriate to start inspections. P. Gehrlein asked the landlords if they would be ready to present and discuss their checklist and parameters at a meeting scheduled for Tuesday, September 7, 2021, at 5:00 p.m., prior to the September Council meeting? On behalf of the landlords, Robert Hoyt, Jr., stated they will be ready to present their information at the September 7th meeting.

B. Behrens stated he feels the inspections should include all Borough homeowners as well as businesses.

Robert Hoyt, Jr. asked about the final decision regarding the firemen's request for insurance money. P. Gehrlein stated the firemen will know the final figures from the Drive Thru Cherry Festival by the end of August and are to give an accounting to the Borough of their financial need. R. Hoyt stated he believes the Borough and Township need to support the firemen who provide public safety to all residents. Mayor Gregory stated the Borough must abide by rules set by Borough Code when distributing money.

R. Hoyt, stated there are no building permits posted in the windows of 1-9 East Main Street and 22 South Lake Street. P. Gehrlein stated he will contact North East Area Code Administration who handles the permits.

B. Behrens asked if the main goal for the residential rental inspections is safety or cosmetic? D. McCumber stated as has been discussed many times before, safety of tenants is the main goal.

Amber Belson, 154 South Lake Street, stated she was upset about money being used for the mural in the underpass when the stairs are unsafe and people are using her driveway. She also stated she believes the Borough should help the fire department. She mentioned there are two petitions on Facebook supporting Captain Lam for the Police Chief position as he is doing a great job and is a North East

resident. P. Gehrlein stated an update regarding the outward search for the Police Chief position will be presented to Council members at the August 16th meeting.

B. Behrens requested "Public Comments" be placed at the end of the agenda also.
