July 6, 2021

The regular meeting of the North East Borough Council was held on Tuesday, July 6, 2021, at 7:00 p.m. at Borough Hall, 31 West Main Street, North East, PA.

CALL TO ORDER:

President David Hall called the meeting to order at 7:00 p.m., at which time the Pledge of Allegiance was recited.

PUBLIC COMMENTS:

B. Behrens, Jr., 97 Wall Street, asked if the Borough was giving the Fire Department \$40,000.00 they requested. P. Gehrlein stated after a meeting with representatives from Crescent Hose, Fuller Hose, the Township and Borough Council, it was decided to entertain the proposal after an accounting of all the proceeds were completed from the Cherry Festival.

B. Behrens asked why North East has two fire fighting companies and not just one. B. Behrens stated they should merge and sell the excess equipment. P. Gehrlein stated the fire companies have completed a feasibility study which indicates the potential to merge the two companies is great since they are basically functioning as one fire company now. However, the fire companies need to decide on how to proceed if both companies agree to merge.

B. Behrens asked why the dates on the bills changed. N. Anderson stated the dates now listed on the bills are the actual read dates. The old software would not permit us to change the dates. The new software permits us to use the actual read dates and then be able to bill for the usage. N. Anderson also stated if a landlord requires a final read, we can still perform that function.

B. Behrens asked about the vacant Police Chief position. P. Gehrlein stated at the motion of Council, the Borough has advertised for the Police Chief position both locally and nationally. B. Behrens asked why the Borough is pursuing applications when Captain Lam is eligible and capable of doing the job. P. Gehrlein stated this is an opportunity to look outside as well as inside the department and the Borough is not discounting Captain Lam's performance and work during this time frame. B. Behrens stated he would encourage Borough Council to strongly consider filling the Police Chief position with Captain Lam.

The auditors are pleased with the new software and how we get the information to them.
