### **HEARING:**

Ordinance No. 915, Amend Non-Uniform Pension Plan Administered by the PMRS Pursuant to Article IV

### **Expense Approval Report**

P. Gehrlein discussed the expense report including the MMO payments for PMRS and chemical needs for the wastewater treatment plant. He stated that all other expenses in the report were typical. D. McCumber motioned to approve the Expense Approval Report as presented. D. Wurst seconded. The motion carried unanimously.

### **PUBLIC COMMENTS:**

Tom Huber, 196 Eastwood Drive, asked Council to demolish the building at West Main Street and Robinson Streets stating his concern that the house is an eyesore in the community. T. Huber also asked about the \$6.5 million grant for Mercyhurst North East, as a majority of that property is in the township. P. Gehrlein stated that he was asked to complete the grant application as the local municipality office due to the project benefiting the entire North East community. He also stated that the Borough will not be obligated past the paperwork completion.

Robert Behrens, 97 Wall Street, stated that the road patching being done in town looks good.

Jon Triana, 50 Blaine Street, asked about the stairs in the underpass on Route 89. P. Gehrlein explained that the stairs are being structurally assessed to determine how they should be addressed for improvement.

D. McCumber asked about the banner that was hung over the underpass on Route 89. Mark Hamman said the Streets Department looked into complaints about the banner but were unable to remove it due to its location on railroad property and the Borough does not have permission to access the area.

After the allocation of \$60,000 to the Fire Training Facility in Gibson Park, the Finance Committee is recommending spending \$120,000 on thirty (30) new streetlights throughout the downtown corridor to match the lights in Gibson Park, \$15,000 to the Shade Tree Commission for planting street trees and replacement trees and \$20,000 for the installation of a digital information kiosk in Gibson Park. B. Beardsley motioned to accept the Finance Committee recommendations as discussed. D. McCumber seconded. After a roll call vote, the motion carried unanimously. The vote was as follows:
