This year we received approximately \$211,000.00 to be applied towards COVID preventative measures, healthcare accessary benefits as well as replenishing any lost revenues and community projects that will benefit a large group of people affected by COVID. B. Beardsley stated the Finance Committee met and agreed to give \$60,000.00 towards the fire departments' training facility. G. Henning motioned to give the fire department \$60,000.00 to be used towards the fire departments' training facility. D. McCumber seconded. After a roll call vote, the motion carried unanimously.
