MINUTES NORTH EAST BOROUGH COUNCIL

Monthly Meeting April 4, 2022

The regular monthly meeting of North East Borough Council was held on Monday, April 4, 2022, at 6:00 p.m. in Council Chambers, 31 West Main Street, North East, PA 16428.

CALL TO ORDER:

Borough Council Vice President B. Beardsley called the meeting to order at 6:00 p.m., at which time the Pledge of Allegiance was recited.

B. Beardsley asked for a motion to approve the revised agenda, stating the need occurred that morning with the addition of a time-sensitive resolution required for the grant application process through Erie

County. A. Belson motioned to approve the revised agenda as presented. R. McGregor seconded. The motion carried.

MINUTES:

H. Jones motioned to approve the March 7, 2022, minutes as presented. T. Luke seconded. The motion carried.

ACCOUNTS PAYABLE:

Expense Approval Report

A. Belson expressed her thanks for including more detailed expense reports to Council members. R. McGregor asked for clarification regarding the number of checking accounts on the report. P. Gehrlein stated that the Borough currently has twelve accounts which are detailed through the report. H. Jones motioned to approve the Expense Approval Report as presented. A. Belson seconded. The motion carried.

PUBLIC COMMENTS:

R. Behrens, 97 Wall Street, asked about the longer billing period dates on the first quarter water, sewer, and garbage bills. N. Anderson stated that the billing period was extended by two weeks in March before the water and sewer rates increased on April 1st, giving customers more time at the lower rates. R. Behrens asked if water meter readings could be moved back to the end of the month as they were in the prior system. P. Gehrlein stated that the meter readings have always been done mid-month to allow time for generating and mailing the bills in a timely manner.

R. Behrens asked that a notice be put in the North East News Journal to remind residents about road safety with lawnmowers. Chief Lam said he would speak with R. Behrens following the meeting regarding the specific incident he described.

UNFINISHED BUSINESS:

Appointment of Ptlm. Jeffery Orzechowski to Full-Time

Chief Lam stated it is the recommendation of the Civil Service Commission to appoint Ptlm. Jeffery Orzechowski to full time. Mayor Triana and R. Behrens also expressed support of the recommendation. T. Luke motioned to appoint Ptlm. Jeffery Orzechowski to the full-time position. R. McGregor seconded. After a roll call vote, the motion carried. The vote was as follows:

Resolution No. 04042022-1, Modification to "OBO" North East Borough's FY 2019 CDBG Program

The resolution had previously been approved in August 2021, but the application was not forwarded by Erie County. This emergency addition to the agenda occurred this morning upon notification

R. McGregor asked about the garbage violations on the Code Enforcement Report. W. Yokom stated that most of the violations involved residents using garbage cans larger than 35 gallons.
