Resolution 12052022-1: Community Development Block Grant Program FY 2019 Modification

P. Gehrlein stated that the presented resolution, which was previously tabled due to public hearing dates, will allow for the reallocation of fiscal year 2019 funding from handicapped accessible curb cut ramps into the streetscape improvement project for the Wall Street area. Resolution 12052022-2: Community Development Block Grant Program FY 2021 Modification

Resolution 12192022-4: PA Small Water and Sewer Grant: Commonwealth Financing Authority

P. Gehrlein stated that the proposed resolution will allow the Borough's application for the PA Small Water and Sewer Grant. Funds from the grant will be used to improve the alleyway behind West Main Street and South Lake Street, addressing rooflines, drainage, sewer line and storm sewer line replacement. H. Jones motioned to approve Resolution 12192022-4: PA Small Water and Sewer Grant: Commonwealth Financing Authority as presented. T. Luke seconded. The motion carried unanimously.

T. Krug, 26 Town Street, asked for clarification regarding which alleyway would be addressed in the presented resolution.

R. Behrens, Jr., 97 Wall Street, asked if traffic patterns on Wall Street would change when the water lines are replaced. P. Gehrlein stated that the traffic pattern ordinance will be completed in early 2023, before the Wall Street water line replacement project begins.

R. Behrens, Jr., 97 Wall Street, asked about the small white house at the corner of West Main and Robinson Streets. P. Gehrlein stated that the property is currently owned by the Erie County Land Bank, who intends to put out the bid for redevelopment of that property rather than tearing down the structure.

R. Hoyt, Jr., 9310 West Main Road, asked how many vacant properties are owned by the Borough. P. Gehrlein stated that the property on Smedley Street is the only property of this kind.
