## **PUBLIC HEARING:**

The public hearing for Ordinance No. 924 – Establishing a Residential/Commercial Rental Inspection and Registration Program began at 6:05 p.m. Borough Council President D. McCumber asked for public comment regarding the proposed Ordinance No. 924.

#### **PUBLIC COMMENTS:**

R. Behrens, 97 Wall Street, asked why the public comment section of the agenda is only available at the end of the meeting. D. McCumber stated that the earlier portion of public comment is for individuals who request to be on the agenda for a specific purpose, whereas the later portion of public comment is open to everyone. B. Beardsley stated that the meeting format follows the bylaws and Robert's Rules of Order.

J. Schneider, 64 Eaton Drive, asked why only one Borough Councilperson visited his house after his request at the previous meeting. He said that some of the issues are slowly being resolved, but that there are still problems with his neighbor after several complaints. J. Schneider stated that he contacted other boroughs in the county and inquired about their code enforcement procedures. He suggested that the North East Borough Council consider following their example of hiring a part-time code enforcement officer, as the condition of the town is deteriorating, and urban blight is increasing.

E. Luke, 38 North Mill Street, asked if meeting minutes could be available within a week of the public meetings. D. Miller, Solicitor, stated that minutes are not official until they have been reviewed and approved by Borough Council at the following council meeting. E. Luke also thanked the Chamber of Commerce and local businesses for their Gibson Days Salute to Veterans last month.

R. Behrens, 97 Wall Street, asked if code enforcement problems were complaint-based only, or if the code enforcement officers routinely checked for compliance, noting several issues he has noticed. D. McCumber stated that he should file complaints about problems he notices, as the code enforcement officers may not be aware.

A. Belson asked J. Schneider if the problems he has with his neighbor are all related to noncompliance with Borough Code. J. Schneider stated that there have been seven (7) complaints made and that the problem is not being corrected. He also restated his recommendation to hire a part-time code enforcement officer. J. Triana stated that chickens are not the only problem in town, as rabbits also cause damage. N. Anderson stated that the Borough had previously employed a part-time code enforcement officer but later decided to staff the position in-house.
