D. Adamus is part of a community-based initiative led by Jake Banta, Pennsylvania Representative, working closely with the Pennsylvania Fish and Boat Commission to preserve the North East Marina. On behalf of the community-based initiative, D. Adamus requested that Borough Council pass a motion permitting North East Borough to be included in the construction of a community-based authority as a public/private partnership. D. Adamus stated that, once constructed and established as a legal entity, the North East Community Marina Authority would be empowered to negotiate the purchase of the North East Marina from the Pennsylvania Fish and Boat Commission. D. Adamus stated that any future updates to, public information regarding, or any formal documentation related to this initiative shall be released in an appropriate time by Representative Banta's office. H. Jones motioned for the North East Borough to participate in the forming of the North East Community Marina Authority as presented. A. Belson seconded. PUBLIC COMMENTS:

T. Huber, 196 Eastwood Drive, asked why a Borough Police Officer would be at the North East School District school board meetings. Chief Lam stated that the school district has requested officers due to staffing shortages from the Sheriff's office. He stated that the North East School District reimburses the overtime expense.

R. Behrens, 97 Wall Street, asked why parking regulations were not enforced during the Wine Fest, and other such community events. Chief Lam stated that the officers offer some leniency during large town events as a courtesy to those in attendance, ticketing only if the situation poses a hazard. R. Behrens stated that parking regulations should never exist if they aren't enforced during special events. D. McCumber stated that visitors should not be discouraged as their attendance at special events benefits the town, small businesses, etc.

R. Adkins, 80 Wellington Street, asked why more of Heard Park was not used during the Wine Fest as Gibson Park was so crowded. R. McGregor stated that the deed to Heard Park does not permit alcohol on park grounds. J. Triana stated that the Wine Fest is a North East Chamber event and that they are responsible for determining how their event is set up within those parameters.
