# AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF NORTH EAST, ERIE COUNTY, PENNSYLVANIA AMENDING ORDINANCES NO. 793 AN ORDINANCE ESTABLISHING AND GOVERNING THE USE OF HEARD MEMORIAL PARK

#### PREAMBLE

**WHEREAS,** The Borough Council, subsequent to extensive investigation and deliberation, is of the opinion that the rules established by the Borough Council of North East Borough through the adoption of Ordinance No. 793 require review and revision from time to time; and

**WHEREAS**, the Borough Council of North East Borough, Erie County, Pennsylvania have reviewed the rules pertaining to the governance of Heard Memorial Park and are recommending the following section be removed from the Ordinance:

#### **SECTION 4- Alcoholic Beverages Prohibited**

The sale, dispensing or consumption of alcoholic beverages in Heard Memorial Park is prohibited

**WHEREAS**, this Amendment to Section 4 of Ordinance No. 793 refers to a Deed Covenant that runs with the land in which the Heard Memorial Park is situated and would only remove the restriction within the Ordinance and the removal of this provision within the Heard Memorial Park Deed Covenant would still be required.

**NOW THEREFORE, BE IT ORDAINED AND ENACTED** by the corporate authorities of the Borough of North East; Erie County, Pennsylvania and it is hereby enacted by the authority of the same as follows:

### SECTION 23: SEVERABILITY

1. Section 4 of Ordinance No. 793 is hereby removed.

**<u>SECTION 2.</u>** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** The provisions of this Ordinance are severable and if any of its provisions shall be held invalid, the same shall not affect or impair any of the remaining provisions of the Ordinance which would have been enacted had such invalid provisions been included herein.

### **EFFECTIVE DATE:**

**SECTION 4.** This is effective immediately upon enactment according to law, and shall remain in effect hereafter until reviserevised, amended, or revoked by action of the Borough of North East
