#### CALL TO ORDER:

Borough Council President A. Belson called the meeting to order at 6:00 p.m., at which time the Pledge of Allegiance was recited.

#### Ordinance No. 935 – Slot Machines: Discussion

A. Belson asked for a motion to rescind the motion to advertise Ordinance No. 935 – Slot Machines as made at the last Borough Council meeting on April 7, 2025. H. Jones motioned to rescind the motion to advertise Ordinance No. 935 – Slot Machines as presented. R. McGregor seconded. After a roll call vote, the motion carried unanimously. A. Belson stated that a committee has been formed to discuss options for addressing the slot machine / PA Skill Games use within the Borough. She stated that the committee, made up of herself, R. McGregor, and H. Jones, have discussed licensing, restricting use to commercial locations, limiting the number of machines per location, applications of the Amusement Tax and Nuisance Code, as well as concerns regarding use by individuals under the age of eighteen (18). She stated that P. Gehrlein will consult with the solicitor and that the committee hopes to present a revised ordinance for advertising at the May meeting.

N. Anderson asked who is responsible for monitoring the use of the machines. A. Belson stated that independent vendors rent spaces within stores, therefore the store employees are not responsible for monitoring use.

B. Morey stated that the conversation should be open, not limited to a committee. She stated that other municipalities have defined arcades with different regulations.

R. Hamman, 9718 Black Road, stated that machines often come from out-of-state vendors. He stated that the social clubs with non-profit status should not be penalized.

H. Jones stated that she doesn't want to take the games away from the clubs, but that there needs to be uniformity and that the ordinance cannot discriminate between types of organization.

R. Adkins, 80 Wellington Street, asked if the locations need to post a license to operate the games. A. Belson stated that they are currently unregulated by the state.

B. Beardsley stated that the discussion could continue forever, but that the next step should be contacting the solicitor to see what is allowable and moving forward.

## Erie County 911 Dispatch Intergovernmental Cooperation Agreement

P. Gehrlein stated that the proposed agreement from the previous meeting has been amended and updated, as presented, including a termination clause. R. McGregor motioned to approve the Erie County 911 Dispatch Intergovernmental Cooperation Agreement as presented. T. Luke seconded. After a roll call vote, the motion carried unanimously.
