## Ordinance No. 936 – Property Maintenance Code

P. Gehrlein stated that the Borough received an objection to the signing of Ordinance No. 936 – Property Maintenance Code from Mayor Morey. The Mayor's objections were presented to Council and attached to these minutes.

N. Anderson responded to the Mayor's objections regarding the following points: First, she stated that the Mayor's objection stated that the ordinance was not properly advertised. N. Anderson read the advertising requirements from PA Borough Code and stated that individual notification was not required. Secondly, she stated that the Mayor's objection stated that the impact on individual businesses would be burdensome, given the example of interior temperatures. N. Anderson noted exceptions listed in the IPMC. Thirdly, she stated that the Mayor's objection stated it was not accurate to include that a child would've died if the standards were different. N. Anderson stated that we cannot be sure, but that unfit, unsanitary, hazardous structures should be addressed. Fourth, N. Anderson asked if the owners of a property are deceased, how the Borough could take legal action. P. Gehrlein stated that, in the case of a deceased owner, the property goes to probate in the court system and a lien can be placed for minor maintenance such as mowing. D. Pekelnicky stated that states are required to advertise estate executors. D. Pekelnicky also stated her own objection that the Borough did not advertise Ordinance No. 936 correctly, advising that it should be removed through veto, readvertised, a new public hearing held, then open to a vote.

B. Morey stated that her decision to veto came with hours of research and thought, but that she does not want the conversation to end. She wants to move forward without a burdensome code.

N. Anderson motioned to overturn the Mayor's objection to Ordinance No. 936 – Property Maintenance Code as presented. There was no second, therefore the Mayor's objection stands.

#### **NEW BUSINESS:**

#### Ordinance No. 937 – Local Government Unit Debt Act

P. Gehrlein stated that the proposed ordinance is a requirement of the PENNVEST Loan application. He stated that the Water Authority is the indebted party and that the Borough provides the guaranteeing base through water sales revenues. B. Beardsley motioned to approve Ordinance No. 937 – Local Government Unit Debt Act as presented. N. Anderson seconded. After a roll call vote, the motion carried unanimously. The vote was as follows:

C. Burgess, 9205 Station Road, asked for updates regarding the Senior Center building. P. Gehrlein stated that the Borough received notes back from GECAC's solicitor regarding the lease. He stated that a facility use agreement and hourly fee schedule would be available soon.

P. Stempka, 104 Isabella Street, asked if there was currently a charge being added to reservations for the Senior Center. P. Gehrlein stated that nothing would change until a new agreement was passed.

S. Reed, 1700 North Pearl Street, thanked the Water Department for the Porta-John at Eaton Reservoir, as well as thanking them for maintaining the beautiful area around the reservoir.

D. Pekelnicky, 36 West Main Street, thanked the Borough for being responsive to issues in the community.

A. Belson stated that T. Luke was still in the hospital recovering from his accident and surgery, but that she hopes he can return soon.
