The regular monthly meeting of North East Borough Council will be held Monday, August 4, 2025, at 6:00 p.m. in Council Chambers.

CALL TO ORDER:

Borough Council President A. Belson called the meeting to order at 6:00 p.m., at which time the Pledge of Allegiance was recited.

R. McGregor offered the invocation.

CITIZENS TO BE HEARD:

Gary Cunningham and Bill Klenz - Cherry Festival

B. Klenz read a statement on behalf of the Fire Department. He expressed their disappointment at the disrespect shown by the Borough to allow another event to occur at the same time as the Cherry Festival that others profited from at the expense of the firemen.

A. Belson stated that it was an event held on private property, within the commercial zoning regulations. P. Gehrlein stated that a temporary Zoning Occupancy permit was issued as the use of the property met Zoning requirements. R. Hoyt stated that temporary occupancy permits require running water, illuminated exit signs, etc. P. Gehrlein stated that Building Occupancy Permits require those things, but that the Borough only issues Zoning Permits, not Building Permits.

NEW BUSINESS:

Code Enforcement Discussion

Ordinance No. 815 A – Dangerous Structures: Repeal and Revise Ordinance No. 856 – Common Nuisance: Repeal and Revise Ordinance No. 908 – Property Maintenance: Repeal and Revise

P. Gehrlein stated that the proposed draft ordinances are an effort to revise and unify the current code enforcement and property maintenance standards. He asked council to review and discuss the drafts presented, ask questions, offer revisions, etc, to be presented at a future meeting.

Subdivision Plan – 80 East Main Street

P. Gehrlein stated that the Borough received a request from the owner of the property at 80 East Main Street to subdivide the parcel for future development. He stated that the proposed plans have been approved by Erie County Planning and the North East Borough Planning Commission. H. Jones motioned to approve the Subdivision Plan – 80 East Main Street as presented. B. Beardsley seconded. After a roll call vote, the motion carried unanimously. The vote was as follows:

North East Borough Personnel Policies and Procedures Manual

P. Gehrlein stated that the North East Borough Personnel Policies and Procedures Manual discussion will be tabled until after the personnel committee has had time to meet and review the document.

Tax Abatement Program Information – Ryan McGregor

R. McGregor presented a proposal to offer tax abatement as an incentive for property improvements. He stated that the proposed ordinance would allow property owners to receive a graduated discount on their taxes based on the assessed value after improvements. N. Anderson stated that the abatement should only apply to the improved value of the property, not the entire assessment. She also stated that the work should be fully completed before the abatement is granted. She also asked why a new ordinance was necessary when Ordinance No. 918 provides the same abatement incentive. B. Beardsley stated that he agreed with N. Anderson that the abatement should only apply to the increased assessment, not the whole assessment of the property.

L. Belknap, 8 Bank Street, asked if the abatement incentive was available to landlords as well, stating that council members with rental properties should not be making decisions on something they would benefit from financially. D. Belknap asked how often improvements could be made that resulted in tax abatement.

R. McGregor stated that he would review the proposed changes compared to the current ordinance.

Neighborhood Task Force – Letters of Intent

A. Belson stated that three (3) letters of intent were received for the Neighborhood Task Force. B. Morey stated that all three should be approved. L. Belknap stated that the request for members of the task force should be readvertised in a more inclusive way to represent individuals with physical and mental disabilities. B. Morey stated that they are seeking different perspectives on the committee and are not discriminating against anyone. She stated that the task force is meant to protect and help people.

- N. Anderson asked where the liability would fall if someone from the task force was injured while volunteering. P. Gehrlein stated that liability would fall on the property owner. P. Gehrlein stated that a new advertisement could be placed.
- R. McGregor motioned to accept nominations and readvertise for the Neighborhood Task Force. H. Jones seconded. After a roll call vote, the motion carried 5-1. The vote was as follows:

North East Community Center: North East Crazy Quilters

A. Schmidt, 83 Niagara Street, representing the North East Crazy Quilters, stated that their proposal was submitted for use of the Community Center building. B. Beardsley stated that the letter did not include a proposal and asked what their request was. A. Schmidt stated that the quilters organization wishes for the previous agreement of \$35 per month to stay the same. A. Schmidt and other members outlined the various personal and philanthropic projects that their organization does. R. McGregor asked if a rate of \$2.50 per hour, totaling \$65 per month at the requested schedule, would be agreeable. C. Burgess said yes.

P. Gehrlein asked if the new rate applied to all groups and individuals requesting use of the building, or just the North East Crazy Quilters. B. Morey stated that the quilters should be grandfathered in as an existing group. R. Adkins also stated her opinion that the quilters should be grandfathered in and also asked if a deposit was required to ensure that the building is left clean.

T. Luke motioned to approve the North East Community Center: North East Crazy Quilters rate of \$2.50 per hour for 13 hours per week on Fridays and Saturdays, twice per month. R. McGregor seconded. After a roll call vote, the motion carried unanimously. The vote was as follows:
