#### **CALL TO ORDER:**

A. Burniston, 11751 Peabody Road, spoke regarding the proposed MOU between the Borough and Marina Authority. She stated that the Authority is seeking funding through ECGRA to develop a plan for the marina and need the MOU in order to apply for grant funding through ECGRA.

E. Mascharka, 175 18 Mile Lane, stated that an MOU was being presented to both the Borough and Township to show a coordination of effort between the municipalities and the Authority.

P. Stempka, 104 Isabella Street, stated that she submitted letters from Powerful Pink Warriors and North East in Bloom, but that they are not on the agenda. She asked that the Powerful Pink Warriors be given the same rental rate of \$2.50 as the Quilters for using the North East Community Center. P. Gehrlein stated that Borough Council had previously asked the office to handle the administration of the North East Community Center and stated that the same rate would apply to their group. P. Stempka also asked that the fee be waived for North East in Bloom considering all the work they do for the town.

Miller, solicitor, stated that the Borough can assist the Authority, but that the regulatory guidance should be provided by the Marina Authority's solicitor. A. Burniston stated that the section on regulatory guidance could be removed. E. Mascharka stated that the MOU is required for the grant to be issued. He stated that the funds would be used for building a strategic plan. He also stated that the grant is a 50% match, which would be provided by the Marian Authority. H. # **PUBLIC COMMENTS:**

- D. Pekelnicky, 36 West Main Street, gave kudos to the Borough for their work installing the manhole on her property. She said the Borough Supervisors and Contractors were great to work with.
- P. Stempka, 104 Isabella Street, stated that while meetings are often filled with negativity, she wanted to share that the new street lights and awning lights on Main Street look beautiful.
- E. Urbanowicz, 9470 East Lake Road, stated that the Borough needs to carefully consider the character and qualifications of who is chosen to fill vacancies on the marina board. He stated his concerns that the current chairman of the Marina Authority is acting outside of the allowable parameters of the position.

R. Burniston, 11751 Peabody Road, provided a written statement (attached to the minutes) and expressed his concerns regarding the management of the Marina Authority. He expressed concern regarding leadership, conduct, intimidation and harassment, and the lack of transparency among groups of people involved in the Marina.

A. Burniston, 11751 Peabody Road, stated that the largest obstacle the Marina Authority is facing is the dynamic of the board. A. Belson stated that Borough Council could not remove someone from the Marina Authority board, as they are their own legal entity. D. Miller agreed that the Marina Authority is a separate entity that and that Borough Council does not have the authority to remove board members. A. Burniston asked them to be careful in selecting who fills the next vacancy.
