NEW BUSINESS:

Draft Ordinance No. 939 - Regulations for Motorized and Non-Motorized Transportation

J. Dodd, 14 East Division Street, stated that he reviewed the proposed draft and agreed that safety is a top concern. He stated that there should be an opportunity for compromise, as many people and children ride e-bikes and should not be banned from doing so.

A. Belson stated that this is the beginning of a bigger conversation regarding various kinds of transportation, stating that there have been problems with adults and children in street traffic and on the sidewalks.

H. Jones stated that she agrees with Mr. Dodd, stating that we shouldn't take things away from kids in town, as there are already limited options. She stated that violations should be treated similarly to truancy, holding parents accountable and taking away the bikes after a set number of problems.

J. Lamb, 8841 Findley Lake Road, stated that her son rides an e-bike and uses a helmet, safety whistles, etc. She stated that age 16 is too high of a requirement.

A. Adams, 90 Ackerman Lane, stated that council should consider different classes of e-bikes, as some are pedal-assist and others are full-throttle.

A. Belson stated that a committee is a good idea to begin discussions. She stated that she will head the committee, joined by Mayor Morey, Chief Lam, and community members.

Subdivision Plan - Whistle Run

P. Gehrlein stated that the proposed subdivision plan is a replotting of property lines. He stated that the plan has already been approved by the North East Borough Planning Commission and the Erie County Department of Planning. T.
